

1	3 rd of May 2022	UK time: 13:00 to 16:00 BST	Participating Students choose a subject from a list of curated by professors and Refinitiv professionals, the latter of which will give a presentation introducing the Hackathon and the help they will provide throughout.
		French time: 14:00 to 17:00 CET	
	18 th of May 2022	UK time: 9:00 to 12:00 (midday) BST	Participating Students give a presentation (i) explaining their subject choice, (ii) giving an outline of their goals in this Hackathon and (iii) showing their work this far. Jurors will give feedback on which Students can work before the last step; this will hone-in on the technical needs of the Students and demands of the Jurors. This is an elimination stage, where jurors (including professors) will choose the top 3 teams per University who will go on to the last stage.




Who Are We

- Its Workspace is the core of all financial and data-heavy workflows.







Context




Why these Subjects

Why were these topics chosen?

- ESG: Environmental, Social and Governance subjects are sensitive topics in society overall, made more important recently by Biden's promise to halve US emissions by 2030. Specifically, Finance sectors are adapting and has to improve the "Sustainability" aspects of all job roles.
- Investment Banking: Some of the biggest deals witnessed to day were closed during recent worldwide lockdowns. In addition, we saw many IB clients innovatively transform their skill-sets towards more technical day-to-day workflows (e.g.: coding).

We have a strong feeling that young professionals' future in the world of Finance is going to evolve around those challenges.

- Bring forward a start-up structure to put yourselves in the shoes of professionals in the field of choice.







Refinitiv Datastream

You may choose to investigate macroeconomic effects. For this, you may use workspace (via the <u>Economic Monitor</u>), but we would encourage you to also look into <u>Datastream</u>:

- Refinitiv Datastream is an industry-leading analytical data source that enables detailed exploration of relationships between data series. Perform correlation and relationship analysis, test investment and trading ideas, and research countries, regions and industries with time series available from the 1900s onwards.




